**TERMINATION OF SECURITY INTEREST AND REASSIGNMENT
IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST AND REASSIGNMENT IN TRADEMARKS**, dated as of December 21, 2007, is made by Harris N.A. formerly known as Harris Trust and Savings Bank (the "Secured Party").

WHEREAS, Coffman Stairs, LLC (the "Grantor") has assigned, mortgaged and pledged certain personal property to the Secured Party and granted such Secured Party a security interest therein, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby terminates and releases all mortgages, liens, and security interests granted to the Secured Party and reassigns to Grantor any and all rights conveyed to the Secured Party in the following Trademarks:

1. all of the Grantor's Trademarks to which the Grantor is a party including those referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
