RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is dated as of January 10th, 2008 by CHEVY CHASE BANK, FEDERAL SAVINGS BANK ("Chevy Chase Bank").

WHEREAS, Chevy Chase Bank and RS Information Systems, Inc., a Maryland corporation ("Grantor"), entered into that certain Security Agreement, dated as of 11/15/2004, ____ (the "Agreement");

WHEREAS, the Agreement granted Chevy Chase Bank a security interest in, among other things, certain trademarks, tradenames, trademark registrations, service marks, trade styles, terms, designs and trademark applications ("Trademarks"), including, without limitation, the Trademarks listed on Schedule A attached hereto as security for the obligations of Grantor;

WHEREAS, Chevy Chase Bank recorded the Agreement on November 16, 2004 at Reel 3083, Frame 0443 in the United States Patent and Trademark Office; and

WHEREAS, Grantor has satisfied all of the obligations and has requested that Chevy Chase Bank release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Chevy Chase Bank hereby agrees as follows:


Chevy Chase Bank hereby fully releases and terminates its security interests in and liens on:

- (a) all of Grantor's now existing or hereafter acquired right, title and interest in and to all Trademarks which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Trademarks have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;
- (b) the goodwill of Grantor's business connected with or symbolized by the Trademarks; and
- (c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Grantor against third parties for infringement of the Trademarks or of any license with respect thereto.

Chevy Chase Bank further agrees, at the sole cost and expense of Grantor, to perform all acts reasonably necessary to effect the release and termination of its security interest and liens, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.
