This TRADEMARK ASSIGNMENT is made between Miami Tribe of Oklahoma Business Development Authority, a subordinate economic enterprise and political subdivision authorized and incorporated under the Miami Tribal business Action of 199 by the Miami Tribe of Oklahoma, a federally recognized Indian tribe organized under Section 3 of the Act of June 26, 1936 (48 stat. 1967) ("Assignor") and Rocket Gaming Systems, LLC, a Delaware limited liability company ("Assignee").

WHEREAS Assignor is the owner of the following trademarks ("Marks"):

ALL WAYS PAYS ( which is the subject of U.S. Registration No. 3,159,349);  
SURE SHOT (which is the subject of U.S. Registration No. 3,159,350);  
WHOPPER (which is the subject of U.S. Registration No. 3,230,145); and

- (ii) the goodwill of that portion of Assignor's business connected with, pertaining to, and symbolized by the Marks; and
- (iii) the ownership of all causes of action for, and claims for damages by reason of infringement of the Marks, which actions arose prior to the date of execution hereof.

2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.
