**ARTICLES OF MERGER
OF
PETROLEUM PLACE ENERGY SOLUTIONS, L.P.
(a Texas limited partnership)
AND
P2ES INVESTMENTS, LLC
(a Delaware limited liability company)
WITH AND INTO
P2ES MANAGEMENT, LLC
(a Texas limited liability company)**

Pursuant to the provisions of Section 2.11 of the Texas Revised Limited Partnership Act and Article 10.03 of the Texas Limited Liability Act and the title applicable to each domestic filing entity identified below, the undersigned parties do hereby execute the following Articles of Merger for the purpose of merging Petroleum Place Energy Solutions, L.P., a Texas limited partnership, and P2ES Investments, LLC, a Delaware limited liability company (collectively the "Non-Surviving Entities"), with and into P2ES Management, LLC, a Texas limited liability company (the "Surviving Entity") effective as of June 30, 2007 (the "Effective Date"). The Non-Surviving Entities and the Surviving Entity shall sometimes collectively be referred to herein as (the "Constituent Entities").

1. The names of the Constituent Entities and the states under the laws of which they are organized are as follows:

3. An Agreement and Plan of Merger (the "Plan") between the Constituent Entities has been approved and adopted as required by the laws of the jurisdiction of formation of each organization that is a party to the merger and by the governing documents of those organizations.

4. Petroleum Place Energy Solutions, L.P. has complied with the provisions of its agreement of limited partnership regarding furnishing partners copies or summaries of the Plan or notices regarding transactions contemplated thereby.

5. The signed Plan is on file at the principal place of business of the Surviving Entity at 1221 Lamar, Suite 1300, Houston, Texas 77010. On written request, a copy of the Plan will be furnished without cost by the Surviving Entity to any member or partner of any of the Constituent Entities.

7. The Surviving Entity shall be responsible for the payment of all applicable filing fees and franchise taxes, if any, of the Non-Surviving Entities, and the Surviving Entity shall be obligated to pay such fees and franchise taxes if the same are not timely paid

8. The merger will become effective on June 30, 2007.
