2. The Assignor does hereby grant to the Assignee a Power of Attorney to execute and file any documents required to give effect to the terms of this Assignment should the Assignor refuse or be unable to execute such documents.
3. This Confirmation of Trademark Assignment shall be binding upon the parties hereto as well as upon their successors and assigns.

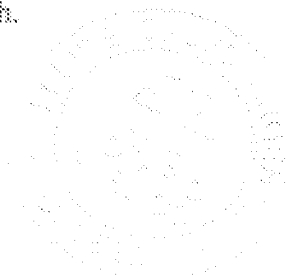
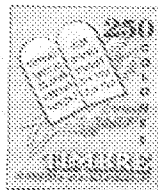

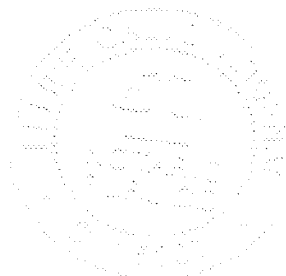
