RELEASE OF TRADEMARK SECURITY INTEREST ASSIGNMENT

THEREFORE, in consideration of the sum of One Dollar (\$1.00) in hand paid, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has released, discharged, assigned and transferred, and by these presents does hereby release, discharge, assign and transfer unto Assignee, its successors or assigns, the entire right and interest that Assignor may have in and to (i) the Trademarks, (ii) any applications and registrations that may be related thereto, (iii) any renewals and extensions that may be granted thereon, together with the goodwill connected therewith and any right to recover for past infringement thereof and other past injury thereto, and (iv) any agreements under which Assignor licensed any rights to use the Trademarks.

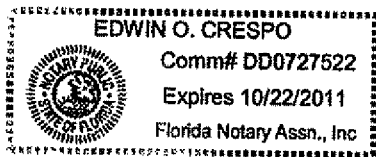
