B The Assignor has agreed with the Assignee for the transfer of the Trade Mark to the Assignee on the terms set out in this agreement.



**IT IS HEREBY AGREED AS FOLLOWS:**

- 1 In the pursuance of the said agreement and in consideration of the sum of one pound (£1.00), (the receipt of which the Assignor acknowledges), the Assignor assigns to the Trade Mark with full title guarantee together with any rights built up through the use of the Trade Mark including the right to bring proceedings for passing off and together with the goodwill in the Business built up by reference to the marks.
- 2 The Assignor confirms authorisation for the representatives of the Assignee to execute the forms of application to record on the national Registers the change of proprietorship effected in this agreement.
- 3 The assignment shall be governed by and construed in accordance with



English law. The parties irrevocably agree that the Courts of England are to have exclusive jurisdiction to settle any dispute which may arise out of or in connection with this assignment.
