TRADEMARK RELEASE, effective as of this 19th day of December, 2007, given by DEUTSCHE BANK AG NEW YORK BRANCH, as Collateral Agent ("Agent") with principal offices at 60 Wall Street, New York, NY 10005, to ACI Billing Services, Inc., a Delaware corporation ("Grantor"), with principal offices at 2700 Patriot Boulevard, Suite 150, Glenview, IL 60026, as follows:

WITNESSETH
