Article I of the Articles of Organization of Super Clean Acquisitions, LLC is hereby amended in its entirety to read as follows:

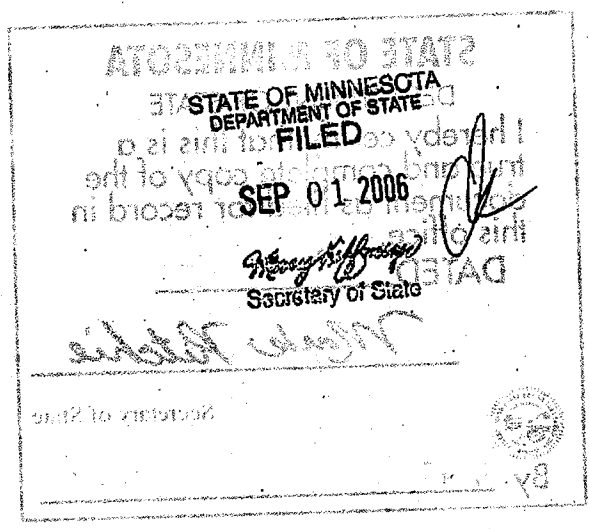
1.01 *Name.* The name of this limited liability company is: SuperClean Products, LLC.
