NOTICE OF ADDITIONAL TRADEMARKS AND GRANT OF SECURITY INTEREST

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, TOKYOPOP hereby:

1. appends the Additional Trademarks to the Security Agreement and grants to Secured Party, any and all security interests, right, title and interest of TOKYOPOP, pursuant to the Security Agreement, in and to the Trademarks more fully described on Exhibit C-4, together with associated goodwill; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the grant hereby given.

TOKYOPOP does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Trademarks granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
