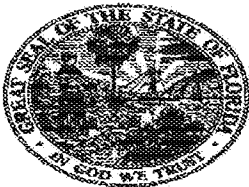

**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
SYSTEM ONE SOLUTIONS, INC.**

This amendment was adopted on the 29th day of August, 2001

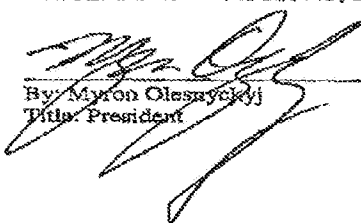
ARTICLE IV
