3. The Agreement of Merger has been approved and executed by both the corporation and limited liability company.

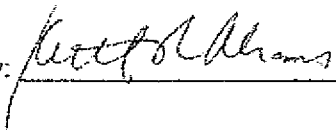
4. The name of the surviving limited liability company is Bayer HealthCare LLC.
