TRADEMARK ASSIGNMENT

WHEREAS, Thermal Dynamics Corporation, a Delaware corporation with offices at 16052 Swingley Ridge Road, Suite 300, Chesterfield, Missouri 63017 ("Assignor"), acquired ownership of U.S. Trademark Application Ser. No. 78/890,129 for the mark AUTOCRAFT (hereinafter this trademark and trademark application shall be referred to collectively as the "Mark") from the original applicant, Thermal Arc, Inc. by way of merger of Thermal Arc, Inc. into Thermal Dynamics Corporation effective April 1, 2007;

WHEREAS, Victor Equipment Company, a Delaware corporation with offices at 16052 Swingley Ridge Road, Suite 300, Chesterfield, Missouri 63017 ("Assignee"), acquired all of the assets of Thermal Dynamics Corporation, including the Mark, pursuant to an Assignment and Assumption of Assets agreement between Thermal Dynamics Corporation and Victor Equipment Company also dated April 1, 2007;

WHEREAS, Assignor and Assignee desire to confirm the assignment of all of Assignor's right, title and interest in and to the Mark, including U.S. Trademark Application Ser. No. 78/890,129; and

WHEREAS, Assignee has acquired and is acquiring the portion of Assignor's business to which the Mark pertains, which business is ongoing and existing.

NOW THEREFORE, for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:



Assignor has, and hereby does, sell, assign and transfer unto Assignee the entire right, title and interest in and to the Mark and any registration issuing therefrom, together with the goodwill associated therewith, and the right to sue for, and recover for, any past infringements thereof, to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had no sale and assignment of said Mark been made.

2. Assignor further agrees to execute such further documents reasonably required by Assignee to secure and enforce the rights granted to Assignee under this Assignment.

This Trademark Assignment is deemed to be effective as of April 1, 2007.
