TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Trademark Assignment"), dated October 31, 2007 (but effective November 2, 2007), is made by ENTEK Manufacturing Inc., an Oregon corporation having its principal place of business at 250 N. Hansard Avenue, PO Box 39, Lebanon, OR 97355 ("Assignor") to ENTEK International LLC, a Delaware limited liability company having its principal place of business at 250 N. Hansard Avenue, PO Box 127, Lebanon, OR 97355 ("Assignee").

RECITALS

A. Assignor and Assignee are parties to a certain Acknowledgement of Technology Ownership and Assignment, dated as of November 2, 2007, by and among ENTEK Holding LLC, Emark Inc., Amtek Research Inc., Ore-Medix LLC, Amtek Research International LLC, ENTEK International Limited, ENTEK Membranes LLC, Assignor and Assignee (the "Purchase Agreement");

B. Assignor has adopted and used in commerce, and owns all right, title and interest in and to the trademarks set forth in Schedule A, attached hereto and made a part hereof, together with all registrations and applications for registration thereof, all common law rights with respect thereto, and all rights to sue and recover for past, present and future infringement thereof (collectively referred to herein as the "Assigned Trademarks");

C. Assignee wishes to acquire, and Assignor wishes to transfer to Assignee Assignor's entire right, title and interest in and to the Assigned Trademarks; and

D. Assignee and Assignor desire to record the assignments set forth in this Trademark Assignment.

AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee Assignor's entire right, title and interest in and to the Assigned Trademarks, including, but not limited to, all benefits, privileges, causes of action, and remedies relating to such Assigned Trademarks, including, without limitation, the exclusive rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement thereof, (c) grant licenses or other interests therein and (d) otherwise fully and entirely stand in the place of Assignor in all matters related thereto. The foregoing includes, and Assignor hereby assigns, transfers and conveys to Assignee, all goodwill symbolized by the Assigned Trademarks. Assignee accepts such assignment, and assumes (and shall pay, perform and discharge when due) all obligations with respect to such Assigned Trademarks from and after the date of this Trademark Assignment.

Assignor agrees, at Assignee's expense, to take such further action and to execute such additional documents as Assignee may reasonably request to carry out and fulfill the purposes and intent of this Trademark Assignment.

This Trademark Assignment may be executed in one or more counterparts, via facsimile or other form of electronic transmission (including delivery of a scanned signature via email), each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

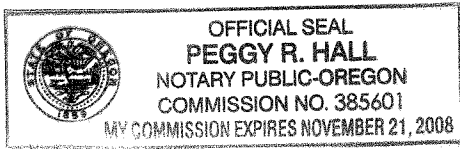


