**TRADEMARK ASSIGNMENT**

This Trademark Assignment ("Assignment") is effective January 10, 2008 by and between Wells Fargo & Company, a Delaware Corporation (hereinafter "Wells Fargo") and the State of Wisconsin ("State"), acting individually and in its capacity as Trustee of the College Savings Program Trust.

WHEREAS, Wells Fargo is the owner of the trademark "EDVEST and Design" in connection with conducting a State of Wisconsin-sponsored college tuition savings program, namely, U.S. Reg. No. 2,738,075 registered on July 15, 2003 and the trademark "TOMORROW'S SCHOLAR" in connection with a college savings program, namely, U.S. Reg. 2,542,920 registered on February 26, 2002 (the "Marks");

WHEREAS, Wells Fargo and State, along with other parties, have executed a Contract for Program Management Services to the Wisconsin College Savings Program dated May 1, 2006 (the "Contract") that describes the Wisconsin College Savings Program and the services certain Wells Fargo subsidiaries provide in connection with this Program;

WHEREAS, the Contract provides that the State is the owner of the Marks and contains a license back to certain Wells Fargo subsidiaries;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo hereby transfers, conveys, and assigns to State, its successors and assigns, Wells Fargo's entire right, title and interest in and to the Marks, including, without limitation, all common law and statutory rights related thereto along with the goodwill associated therewith; all rights of renewal and extension; and the right to sue for and recover damages and profits for any past, present or future infringements thereof.

The Marks are assigned hereunder on an as is basis. Wells Fargo expressly disclaims all warranties relating to the Marks, including any warranties that the Marks are valid or that they do not infringe on the rights of any third party.
