
AND WHEREAS the Assignor has agreed to assign the said Trademarks to the Assignee together with the goodwill of the business associated with said Trademarks;

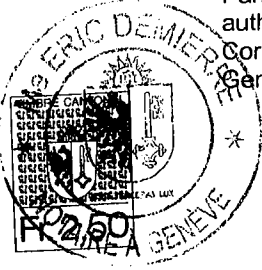



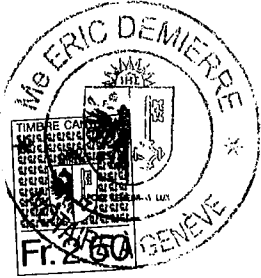
