The rights assigned herein are not geographically limited and are co-extensive with any and all rights of Asian in the United States and throughout the world in and to the FF marks and registrations. Asian agrees to do any reasonable acts and execute all papers reasonably requested by Troxel, at Troxel's expense, to perfect this Assignment Agreement and the terms hereof.

This Assignment Agreement shall be binding upon and inure to the benefit of the parties and their respective affiliates, subsidiaries, parents, successors, and assigns.

Asian warrants and represents that, to the best of its knowledge and belief, it has not pledged or assigned the FF marks and registrations nor entered into any agreement, license, release or order that restricts the right of Asian or Troxel to use the FF marks or registrations in any way, nor does this Assignment Agreement violate any security agreement, indenture, order, or other instrument or agreement to which Asian is a party;

Wherefore, the parties have caused this Assignment Agreement to be executed by their respective authorized representatives as follows, the same to be effective as of the date of last execution hereof.
