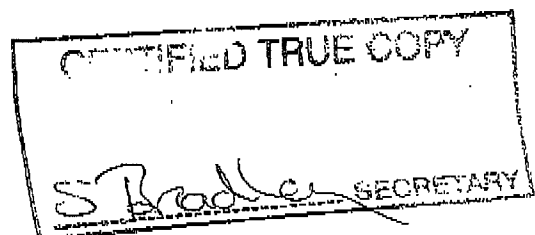

**1. INTRODUCTION**

- 1.1 The Assignor is the proprietor and beneficial owner of Canadian trade mark registration number TMA565909 in Class 39 and 42, and United States trade mark registration number 2796487 in Class 39 and 42 ("the Trade Marks").
- 1.2 The Assignor has agreed to assign the Trade Marks to the Assignee and the Assignee has agreed to accept the assignment of the Trade Marks.

**2. ASSIGNMENT OF TRADE MARKS**


- 2.1 In consideration of the sum of one pound (£1.00) (receipt of which is hereby acknowledged) the Assignor assigns to the Assignee with full title guarantee all right title and interest in and to the Trade Marks, including all statutory and common law rights attaching to the Trade Marks and the right to take action in respect of past infringements of the Trade Marks and to retain any damages obtained as a result of such action.
- 2.2 The Assignor confirms that this Assignment is made with the goodwill attaching to the Trade Marks and the goodwill of the business in which the Trade Marks have been used by the Assignor.
- 2.3 The Assignor shall at the request and expense of the Assignee do all acts and execute all documents in order to vest the Trade Marks in the Assignee.

**3. LAW & JURISDICTION**

This Deed shall be governed by and construed in accordance with English law and the parties submit to the non-exclusive jurisdiction of the English courts.
