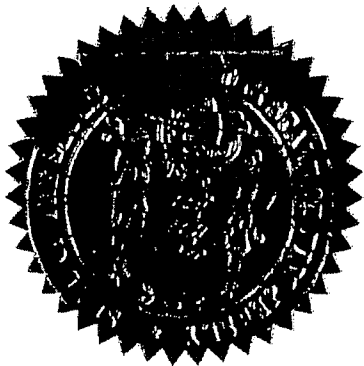

Pursuant to the provisions of Sections 14A:9-1 (2) (a), 14A:9-2 (4) and 14A:9-4 (3) of the New Jersey Business Corporation Act, ALCAN PACKAGING PHARMACEUTICAL AND PERSONAL CARE INC., a New Jersey corporation (the "Corporation"), hereby executes the following Certificate of Amendment to its Amended and Restated Certificate of Incorporation:

1. The name of the Corporation is Alcan Packaging Pharmaceutical and Personal Care Inc.
2.
