COPPER MOON TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is entered into this 30th day of April, 2007 by and between Crystal Food Services, LLC, an Indiana limited liability company, ("Assignor"), and Lifesong Coffee, LLC, an Indiana limited liability company ("Assignee").

WHEREAS, Assignor and Assignee have entered into that certain **ASSET PURCHASE AGREEMENT**, dated as of April 30, 2007 (the "Agreement") pursuant to which Assignor agreed to assign to Assignee all right, title, and interest in and to the trademarks listed on **Exhibit A** attached hereto (the "Trademarks").

The assignment of the Trademarks granted herein includes all rights of action accrued, accruing and to accrue under and by virtue of the Trademarks, including all right to sue or otherwise recover for past, present and future infringement and to receive all damages, payments, costs and fees associated therewith. Assignor shall, at its own cost and expense, execute and deliver any and all instruments and documents and take such further actions as may be necessary or reasonably requested by Assignee to document and record with the appropriate authorities the aforesaid assignment and transfer, provided that Assignee shall be solely responsible for filing and recording such documents.

This instrument may be executed in two or more counterparts (delivery of which may occur via facsimile), each of which shall be binding as of the date first written above, and all of which shall constitute one and the same instrument. Each such copy shall be deemed an original, and it shall not be necessary in making proof of this instrument to produce or account for more than one such counterpart.
