ASSIGNMENT

WHEREAS, on or about March 23, 1996, Christopher's Men's Stores, Inc., also known as Christopher's, a New York corporation having had its principal place of business in the City of Albany and the State of New York, adopted and began using the mark **CHRISTOPHER'S** for men's formal and business clothing, namely tuxedos, suits and dress shirts; and retail clothing store services; and

WHEREAS, on December 17, 1998, said Christopher's Men's Stores, Inc., filed U.S. Trademark Registration Application, Serial No. 75/607,587, for **CHRISTOPHER'S** for use with said aforementioned goods and services, which application issued on September 26, 2006 as U.S. Trademark Registration No. 3,147,048; and

WHEREAS, on December 6, 2001, said Christopher's Men's Stores, Inc., adopted and began using the mark **THE STYLE LEADER** for retail clothing store services; and

WHEREAS, on January 15, 2002, Christopher's Men's Stores, Inc., in the name of Christopher's (New York corporation) filed, U.S. Trademark Registration Application, Serial No. 76/359,283 for the mark **THE STYLE LEADER** for use with retail clothing store services, which application issued on January 28, 2003 as U.S. Trademark Registration No. 2,680,447; and

WHEREAS, on October 15, 2007, said Christopher's Men's Stores, Inc., also known as Christopher's (New York corporation), sold, assigned and transferred the entire right, title and interest in and to the marks **CHRISTOPHER'S** and **THE STYLE LEADER** and the registrations therefor to Christopher's of Colonie LLC, a limited liability company formed and existing under the laws of the State of New York, having its principal place of business at 131 Colonie Center, #440, in the City of Albany and the State of New York, which sale, assignment


and transfer said Christopher's Men's Stores, Inc., also known as Christopher's (New York corporation), desires to acknowledge, ratify and confirm by this instrument.


NOW, THEREFOR, in consideration of the amount of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Christopher's Men's Stores, Inc., also known as Christopher's (New York corporation), by these presents, does hereby acknowledge, ratify and confirm the sale, assignment and transfer, *nun pro tunc* as of October 15, 2007, unto said Christopher's of Colonie, LLC its entire right, title and interest in and to said marks **CHRISTOPHER'S** and **THE STYLE LEADER** for use with said goods and services, the goodwill symbolized by said marks and said U.S. Registration Nos. 2,680,447 and 3,147,048 therefor, along with the right to recover from past infringement thereof, for its own use and behoof and for its legal representatives and assignees, as fully and entirely as the same would have been held by said Christopher's Men's Stores, Inc., also known as Christopher's (New York corporation), had the sale, assignment and transfer not been made.
