BETWEEN:

- (1) **Amora Maille**, located at 48, Quai Nicolas Rolin, 21000 Dijon, France a company incorporated under the laws of France ("Assignor"); and,
- (2) **Unilever N.V.**, located at Weena 455, 3013 Al Rotterdam (Pays Bas) a company incorporated in The Netherlands ("Assignee").

RECITALS:

- (A) The Assignor is the proprietor of the trade marks set out in the Schedule 1 attached hereto (the "Trade Marks") in the **United States of America**.
- (B) The Assignor has agreed to assign such Trade Marks to the Assignee in accordance with the terms of this Agreement.

IT IS AGREED as follows:

1. ASSIGNMENT

In consideration of the sum of €10 (Ten euros) paid by the Assignee to the Assignor (the receipt and sufficiency of which is hereby acknowledged by the Assignor) the Assignor hereby assigns to the Assignee all of its right, title and interest in and to the Trade Marks together with the goodwill and any common law rights attaching to the Trade Marks, and the right to sue for infringements or other unlawful acts which occurred before the assignment.

2. GOVERNING LAW

This Agreement and the relationship between the parties shall be governed by, and interpreted in accordance with, English law and the parties hereto submit to the exclusive jurisdiction of the English courts for the purpose of enforcing any claim arising under or in relation to this Agreement.




