


Sirs/Madams:

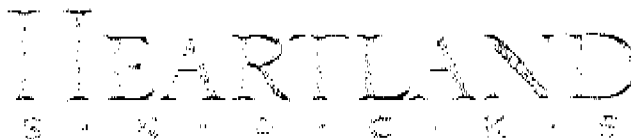
