IT IS HEREBY CERTIFIED:

FIRST: The name of the corporation is Mohawk Paper Mills, Inc. (the "Corporation").


SECOND: The Certificate of Incorporation of the Corporation was filed with the Department of State on August 23, 1972.


THIRD: The Certificate of Incorporation of the Corporation is hereby amended by deleting Article FIRST in its entirety and replacing it with the following:

FIRST: The name of the corporation is Mohawk Fine Papers Inc., which is sometimes hereinafter referred to as the "corporation".

FOURTH: The foregoing amendment of the Certificate of Incorporation of the Corporation was authorized by (i) the unanimous vote of the Board of Directors of the Corporation and (ii) the vote of the holders of a majority of shares of each class of issued capital stock of the Corporation.
