RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST made and entered into this 31st day of January, 2008, by National City Bank, as Administrative Agent for the Lenders as defined in the Security Agreement identified below (the "Administrative Agent") in favor of Fairmount Minerals, Ltd., a Delaware corporation having a place of business at 11833 Ravenna Road, Chardon, OH 44024 (the "Borrower") and Best Sand Corporation, Best Sand of Pennsylvania, Inc., Cheyenne Sand Corp., Construction Aggregates Corporation of Michigan, Inc., D.M.
