PATENT AND TRADEMARK ASSIGNMENT AGREEMENT

This Patent and Trademark Assignment Agreement ("Agreement") is made effective as of April 1, 2007 between Real Estate Business Technologies, LLC ("ASSIGNOR") and RE FormsNet, LLC ("ASSIGNEE").

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Patent and the Marks.

NOW, THEREFORE, for consideration the receipt and sufficiency of which is hereby acknowledged and set forth in the Asset Purchase and Sale Agreement dated April 1, 2007 between ASSIGNOR and ASSIGNEE, which is incorporated herein by reference, ASSIGNOR conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Patent and the Marks, together with (1) the goodwill relating thereto; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to Patent and the Marks, including without limitation, damages and payments for past or future infringements and misappropriations of the Patent and the Marks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Patent and the Marks.


