Assignor further agrees to execute such documents as may be necessary or desirable to effectuate the purposes of this assignment, upon the request of assignee or a successor.

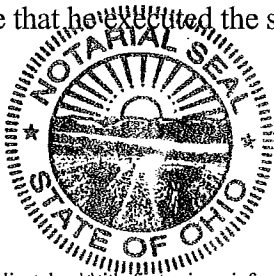
