**RELEASE OF SECURITY INTEREST IN TRADE-MARK**

WHEREAS Golf Town Operating Limited Partnership (the "**Grantor**"), the full post office address of whose principal office or place of business is 3265 Highway 7 East, Unit 2, Markham, Ontario L3R 3P9, is the owner of the Canadian and United States trade-mark registrations and/or applications listed on Schedule "A" attached hereto (collectively, the "**Trade-Marks**");

AND WHEREAS General Electric Capital Canada Inc. pursuant to the Loan and Security Agreement dated November 12, 2004 (the "**GE Loan and Security Agreement**") was granted a security interest in certain Trade-Marks;

AND WHEREAS General Electric Capital Canada Inc. transferred, assigned and set over to BABC Global Finance Inc. its rights and obligations under the GE Loan and Security Agreement pursuant to an Assignment and Assumption Agreement dated September 26, 2005;

AND WHEREAS BABC Global Finance Inc. pursuant to the Second Amended and Restated Loan and Security Agreement dated April 1, 2006 (the "**Loan Agreement**"), was granted a security interest in the Trade-marks;

AND WHEREAS BABC Global Finance Inc. transferred, assigned and set over to Bank of America, N.A. (the "**Secured Party**") its rights and obligations under the Loan Agreement pursuant to an Assignment and Assumption Agreement dated May 26, 2006;

WHEREAS, the Secured Party, effective September 28, 2007 wishes to: (i) release its security interest covering the Trade-Marks; (ii) restore all right, title and interest in and to the Trade-Marks to the Grantor; and (iii) dissolve any and all liens and encumbrances respecting the Trade-Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trade-Marks, and discharges, quit claims and relinquishes unto the Grantor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trade-Marks.
