## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of December 31, 2007, by and between Polygram Holding, Inc., a Delaware corporation with offices at 2220 Colorado Boulevard, Santa Monica, California 90404 ("Assignor"), and Ovation LLC, a Delaware limited liability company with offices at 2800 28th Street, Suite 240, Santa Monica, California 90405 ("Assignee"), with reference to the December 31, 2007 Asset Acquisition Agreement (the "Agreement") between Assignee and Assignor's affiliate, International Music Feed, LLC, to which Assignor is a guarantor.

WHEREAS, Section 2.2 of the Agreement requires Assignor to deliver at closing such further documents as might be required to reflect Assignor's assignment to Assignee of the trademarks identified in Schedule A attached hereto (collectively, the "Marks"), along with the goodwill of the business symbolized thereby; and

WHEREAS, the parties accordingly wish to execute this recordable instrument, assigning all of Assignor's right, title and interest in and to the Marks to Assignee;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby assigns, transfers and conveys to the Assignee all of its right, title and interest in and to the Marks, including without limitation any and all registrations, applications, and/or common law rights for the Marks throughout the world, together with all of the goodwill of Assignor's existing and ongoing business symbolized by or associated with the Marks, and any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto including, without limitation, damages and payments for past, present or future infringements.

2. Assignor and its successors and assigns shall execute and deliver to Assignee any further documents or instruments and shall take any reasonable actions which may be necessary to effect the foregoing assignment or the recordation or perfection thereof.


