## DEED OF ASSIGNMENT OF TRADE MARKS

This DEED OF ASSIGNMENT is made the 10th day of April 2007

### BETWEEN

- (1) ComMedica Limited (in creditors' voluntary liquidation) (Company Number 03722626) whose registered office is at 8 Salisbury Square, London EC4Y 8BB acting by the Joint Liquidators ("the Assignor");
- (2) David John Crawshaw and Finbarr O'Connell both of KPMG LLP, 8 Salisbury Square, London EC4Y 8BB (the "Joint Liquidators"); and
- (3) Visbion Limited (Company Number 05731554) of 72 New Bond Street, Mayfair, London W1F 1RR, United Kingdom ("the Assignee")

### WHEREAS

- (a) The Assignor is the proprietor of the various trade marks registered in the United Kingdom, Canada, the U.S.A., the European Union and Saudi Arabia set out in Schedule I hereto (the "Assets");

### and WHEREAS

- (b) the Joint Liquidators were appointed joint liquidators of the Assignor by a creditors' resolution passed on 23 March 2006;

### AND WHEREAS

- (c) the Assignee purchased the Assets from the Assignor acting by the Joint Liquidators on 28 April 2006;

### AND WHEREAS

- (d) the Assignor now wishes to transfer legal title to the Assets to the Assignee;

### IT IS HEREBY AGREED AS FOLLOWS:

1. In pursuance of this deed the Assignor hereby assigns and transfers to the Assignee all right and title in and with respect to the Assets, such as which were invested in the Assignor immediately before the appointment of the Joint Liquidators, to hold the same unto the Assignee absolutely.

2. The Joint Liquidators, acting on behalf of the Assignor give no express or implied representations or warranties regarding the title as assigned. The Assignee acknowledges that it has entered into this assignment on the basis of its own enquiries and the Assignee has not placed any reliance upon any representation or statement made by the Joint Liquidators or their respective partners, employees, agents, advisors or other representatives.
3. The Assignee will indemnify and hold the Joint Liquidators and their respective partners, employees, agents, advisors and successors harmless against any action, claim, demand, proceedings, damages, expenses, liabilities, costs or loss which the Joint Liquidators, their respective partners, agents, advisors and successors may have made or brought against them as a consequence of entering into this deed of assignment.
4. The rights assigned include any rights built up through use of the Assets including the right to bring proceedings for passing off and the right to bring proceedings in respect of infringement occurring before the date of this deed of assignment.
5. The Assignor confirms authorization for the representatives of the Assignee to execute the documents necessary to record on the relevant Registers the change of proprietorship effected in this deed of assignment.
6. This deed of assignment shall be governed by and construed in accordance with English law and shall be subject to the exclusive jurisdiction of the Courts of England and Wales.
7. It is agreed and acknowledged that the Joint Liquidators enter into this deed of assignment:
  - (a) as agents for the Assignor; and
  - (b) in their personal capacity only to take the benefit of clauses 2, 3 and 7 of this deed;and that they shall not incur any personal liability of whatsoever nature and howsoever arising as a consequence of or in respect of this assignment.

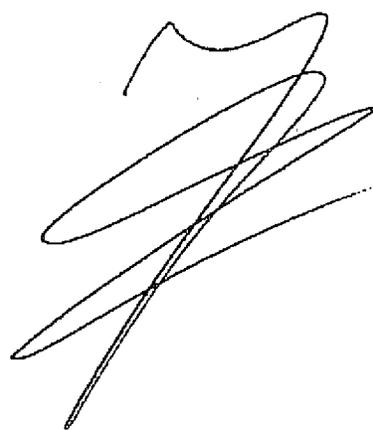

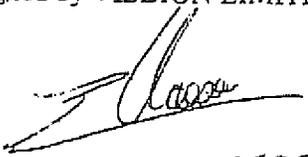

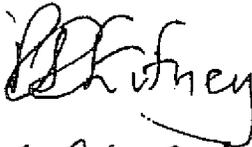
