**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, the Credit Agreement dated as of November 24, 2004 among Concord Music Group, Inc., a Delaware corporation ("Concord"), the banks identified therein (the "Banks"), and HSBC Bank USA., N.A., a national banking association, as the agent (the "Agent") for the Banks (including all annexes, exhibits or schedules thereto, as amended from time to time, the "Credit Agreement"), provided for certain extensions of credit to Concord.

WHEREAS, pursuant to the terms of the Credit Agreement, the Agent and Peacon LLC, a California limited liability company ("Peacon"), entered into that certain Accommodation Trademark Security Agreement (the "Accommodation Trademark Security Agreement"), dated as of November 24, 2004, and filed with the United States Patent and Trademark Office on or about April 4, 2005, at or near Reel 003058, Frame 0822;

WHEREAS, pursuant to the Accommodation Trademark Security Agreement, Peacon granted to the Agent a security interest in the Trademark Collateral (as defined in the Accommodation Trademark Security Agreement) including, without limitation, a security interest in the trademarks and trademark registrations identified on Exhibit A attached hereto (collectively, the "Trademarks"); and

WHEREAS, the Agent has agreed to terminate all liens and security interests in the Trademark Collateral and the Trademarks, and to reconvey to Peacon, without recourse, representation or warranty, any and all right, title, and interest it may have in the Trademark Collateral and the Trademarks pursuant to the Accommodation Trademark Security Agreement as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


