ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, Assignor hereby sells, assigns and transfers over to Assignee, the entire right, title and interest in and to the Marks throughout the world, together with the goodwill of the business symbolized by the Marks, the same to be held by Assignee, its successors, assigns and other legal representatives.




