RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release"), is granted and conveyed as of this 8th day of February, 2008, by Commerce Bank, N.A. as collateral agent (the "Agent"), in favor of RegionalHelpWanted.com, Inc. (the "Obligor").

Agent specifically acknowledges that its security interests in the Released Trademarks are no longer in force.

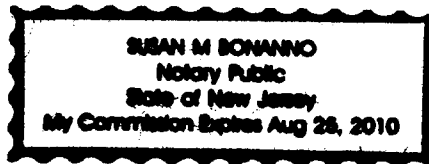
