The ASSIGNOR does hereby covenant and warrant that it has full right to convey the Marks and registrations herein sold and assigned free and clear of any encumbrances of any kind whatsoever.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing or vesting in ASSIGNEE full right, title and interest in the Marks.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Trademarks shall be governed by and construed in accordance with the laws of the State of New Jersey without giving effect to the principles of conflicts of laws thereof.
