## ASSIGNMENT OF TRADEMARK

WHEREAS, CTB IP, INC., a Delaware corporation, having an address at 300 Delaware Avenue, Suite 1253, Wilmington, Delaware 19801, the United States of America (hereinafter "ASSIGNOR") has adopted and is using United States Trademark Application No. 77/288,624 incorporated by reference herein, which trademark application shall be referred to as the "Mark".

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, said ASSIGNOR does hereby assign unto said ASSIGNEE all rights, title and interest in and to said Mark in the United States, together with the goodwill of the business symbolized thereby, and all common law rights, the right to claim prior use of the Mark by ASSIGNOR and all rights to damages or profits, due or accrued, arising out of past infringement of said Mark or injury to said goodwill, and the right to sue for and recover the same in ASSIGNEE or its legal representatives, successors and/or assigns advises that action to procure, maintain, enforce and/or defend said Mark is necessary and/or desirable, ASSIGNOR shall sign all papers and documents and otherwise do all acts reasonable, necessary and desirable in connection with any such action at the cost and expense of ASSIGNEE, its legal representatives, successors and/or assigns.

ASSIGNOR shall execute whatever documents are necessary and/or useful to vest ASSIGNEE'S right in and to said Mark as requested by and at the cost and expense of ASSIGNEE its legal representatives, successors and/or assigns. ASSIGNOR hereby appoints ASSIGNEE attorney-of-fact for executing such documents.
