## TRADEMARK ASSIGNMENT

1. Assignor hereby sells, transfers, conveys, assigns, and sets over unto Assignee, its successors and assigns, Assignor's entire right, title and interest in and to the Seller Marks, together with the goodwill symbolized and represented by the Seller Marks, all common law and statutory rights related thereto, all past, present and future registration and applications therefor, all rights of renewal and extension and the right to recover for damages and profits for past infringements thereof.
2. Assignor agrees to execute and deliver such instruments of sale, transfer, conveyance, assignment and confirmation in order to effectuate the sale, transfer, conveyance and assignment to Assignee of all of Assignor's right, title and interest in and to the Seller Marks.
3. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
4. This Assignment may be supplemented by subsequent assignments executed by one or more of the parties, which assignments may be required to effectuate and/or record this Assignment with the applicable registrars.
5. This Assignment is governed by the laws of the State of Arizona, without regard to conflict of laws principles.
