**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

WHEREAS, ADCOM, a New Jersey corporation ("Grantor") entered into a Trademark Security Agreement dated July 8, 1999 (the "Security Agreement") with SOVEREIGN BANK, a federal savings bank ("Bank");

WHEREAS, Grantor granted to Bank, under the terms of the Security Agreement, a continuing lien and security interest (the "Security Interest") in favor of Bank in, upon and to all of Grantor's intellectual property described in the Security Agreement, including, without limitation, the trademarks, registrations and applications therefor listed in Schedule A and Schedule B hereto and all of the goodwill of the business connected with the use of, and symbolized by, such intellectual property (the "Trademarks");

WHEREAS, Grantor granted the Security Interest to Bank in order to secure the complete and timely satisfaction of Grantor's Obligations (as defined in the Security Agreement);

WHEREAS, Grantor and Bank desire to release the Security Interest in, upon and to the Trademarks;

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, Bank hereby releases the Security Interest in, upon and to the Trademarks; hereby waives and relinquishes all its rights, powers, privileges and remedies under the Security Agreement; hereby sells, assigns, transfers and sets over to Grantor and its successors and assigns any and all right, title and interest in, upon and to the Trademarks and the goodwill associated therewith; and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties under the Security Agreement.

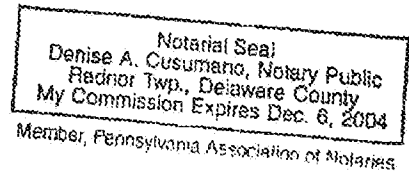
