ASSIGNMENT
TRADEMARK RIGHTS

This Assignment, made and entered into this 3 day of DECEMBER 2007, by and between Sure Seal, Inc. , a Missouri Corporation, located at 11172 State Hwy. O, Mineral Point, MO 63660, herein after referred to as Sure Seal, and Delaware Capital Formation, Inc., a Delaware Corporation, located at 501 Silverside Road, Suite 5, Wilmington, Delaware 19809, herein after referred to as Delaware.

WHEREAS, Sure Seal is the owner of select trademark rights all as identified in the Appendix A, as appended hereto, and herein desires to assign said trademark rights to Delaware; and Sure Seal herein affirms that it has acquired said trademarks from the United States Trademark Office, and Delaware is desirous of acquiring all of said right, title and interest in and to said trademark rights, as currently held by Sure Seal;

Therefore, in consideration of the sum of one dollar (\$1.00), paid by Delaware to Sure Seal, the receipt of which is hereby acknowledged, and Sure Seal acknowledges the receipt of other good and valuable considerations, Sure Seal does hereby sell and assign to the said Delaware all of its right, title and interest in and to said trademarks in Appendix A, the same to be held and enjoyed by the said Delaware to the full end of the terms for which the said trademarks, as fully and entirely as the same would have been held and enjoyed by Sure Seal, if this assignment and sale had not been made; the assignment of said trademark rights includes the transfer and assignment of the said trademarks, their registrations, and the goodwill symbolized by the marks as used upon their identified products in commerce, so that Delaware obtains the full and exclusive rights to the statutory trademarks, and any common law rights incident thereto, pertaining to the trademarks being assigned herein; and, included in the assignment of the trademarks, is the right of Delaware to initiate and prosecute any suit for trademark infringement, that may have occurred prior to the date of execution of this assignment, and to recover and retain any damages sustained as a result of these said infringements.
