Houston Downtown Park Conservancy, a Texas non-profit corporation (the "Corporation"), hereby adopts this Amendment to Articles of Incorporation pursuant to the provisions of Article 1396-4.03 of the Texas Non-Profit Corporation Act (the "Act"),

ARTICLE ONE

The name of the corporation is Houston Downtown Park Conservancy.

ARTICLE TWO

The articles of incorporation of the Corporation are hereby amended as follows:

Article I is hereby deleted in its entirety and replaced with the following:

"The name of the corporation is Discovery Green Conservancy (the "Corporation")."

ARTICLE THREE

This amendment has been approved in conformity with the provisions of the Act and the constituent documents of the Corporation. There are no members of the Corporation having voting rights. The amendments effected hereby were adopted by unanimous written consent of the directors of the Corporation dated November 16, 2006.
