**WHEREAS**

**"Trade Marks"** means those trade marks and applications and all goodwill attached thereto transferred under the Asset Purchase Agreement including, without limitation, the trade marks and applications listed in the schedule hereto;

**"Warranties"** has the meaning ascribed to it in the Asset Purchase Agreement.

- 1.2 The headings in this Agreement are for convenience only and shall not affect the interpretation of this Agreement.
- 1.3 Unless the context otherwise requires, references to clauses are to clauses of this Agreement.

2. **ASSIGNMENT**

Pursuant to and for the consideration set out in the Asset Purchase Agreement, the Assignors hereby assign to the Assignee absolutely all such right and interest as the Assignors have in the Domain Name and Trade Marks.

3. **FURTHER ASSURANCE**

For a period of nine months following completion of this Agreement, the Assignors shall execute and deliver such further documents as the Assignee may reasonably request from time to time at the Assignee's expense by way of further assurance of the rights assigned pursuant to the provisions of this Agreement.

4. **WARRANTIES**

No warranty is given regarding the Intellectual Property except for the Warranties (insofar as they are applicable to the Intellectual Property) which are given subject to the terms of the Asset Purchase Agreement.

5. **NO PERSONAL LIABILITY**

Nothing in this Agreement shall give rise to any personal liability on the part of the Administrators or their firm, partners, employees or agents.

6. **GOVERNING LAW**

This Agreement shall be governed by and construed in accordance with the law of England and Wales. Each party hereby irrevocably submits to the exclusive jurisdiction of the courts of England and Wales over any claim or matter arising under or in connection with this Agreement.






