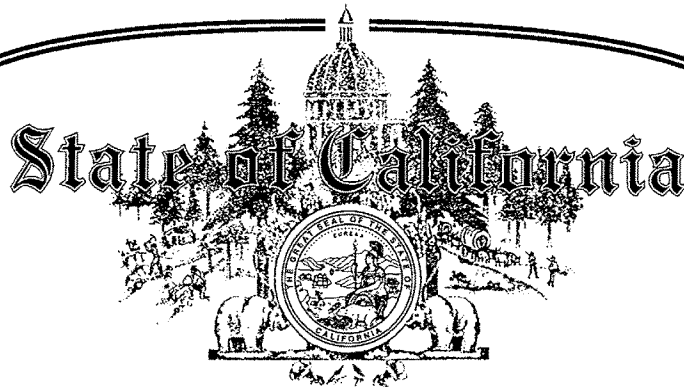

**CERTIFICATE OF AMENDMENT
OF ARTICLES OF INCORPORATION
OF
ADVANCED RESEARCH & APPLICATIONS CORP.**

Robert Arnistead and Victor Sze certify that:

FIRST: They are the President and Secretary, respectively, of Advanced Research & Applications Corp., a California corporation (the "Corporation").

SECOND: Article First is amended to read in its entirety as follows:

"The name of this Corporation is and shall be "RAPISCAN SYSTEMS HIGH ENERGY INSPECTION CORPORATION".

THIRD: The amendment herein set forth has been duly approved by the board of directors.

FOURTH: The amendment herein set forth has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The Corporation has one class of common shares which is entitled to vote with respect to the amendments set forth herein. The number of outstanding shares of such class is 4,572,308. The number of outstanding shares voting in favor of the amendment was 100%, which equaled or exceeded the 50% vote required for the approval of the amendment.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct to our own knowledge.
