Assignor further assigns to Assignee all rights of action for infringement of any of the Marks, which rights of action accrued prior to the effective date of this Assignment.

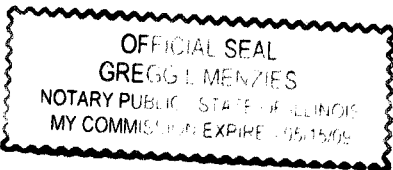
