TRADEMARK ASSIGNMENT

This assignment is effective as of January 31, 2008 and it is entered by and between Videk, Inc., a New York corporation located at 2200 Brighton-Henrietta Townline Road, Rochester, NY 14623, ("Assignor") and United States Postal Service, an Independent Establishment of the Executive Branch of the United States Government, located at 475 L'Enfant Plaza, SW, Washington D.C. 20.260-1136, ("Assignee"). Assignor and Assignee are referred to individually as Party and collectively as Parties.

WHEREAS, Assignor owns the trademark POSTNETVERIFIER and the corresponding U.S. federal trademark registration No. 3161021 for the mark POSTNETVERIFIER (the "Mark");

WHEREAS, Assignee wishes to acquire whatever rights Assignor may possess in the Mark;



NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor agrees to and hereby irrevocably assigns to Assignee any and all right, title and interest in the Mark, together with any goodwill of the business symbolized by the Mark.

Assignee shall have the sole discretion to determine whether the intellectual property rights in the Mark shall be preserved and maintained, registered or renewed in the United States of America or any foreign country and to have any resulting registration issued in Assignee's name as claimant.

This Agreement shall be governed by and construed in accordance with principles of federal law, or if there is found to be no such federal law, then the laws of the State of New York as interpreted by the Second Circuit for the United States Court of Appeals.

The Parties have not relied on any representations, promises, warranties, covenants, statements, or undertakings by the other Party or its counsel other than those contained in this Agreement.
