
ASSIGNMENT OF TRADEMARK APPLICATION

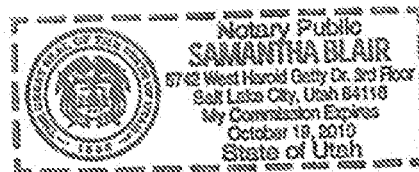
