RELEASE OF GRANT OF SECURITY INTEREST

TRADEMARKS AND SERVICE MARKS

WHEREAS, Triad Healthcare Corporation (formerly Triad Hospitals, Inc.), a Delaware corporation (the “*Trademark Owner*”), entered into a Trademark Security Agreement (the “*Grant of Security Interest*”) in favor of Credit Suisse (the “*Secured Party*”), to secure payment of certain obligations of Trademark Owner to the Secured Party; and


NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:
