RELEASE OF SECURITY INTEREST -- TRADEMARKS

WHEREAS, SUTTON PLACE GOURMET, LLC., a Delaware limited liability company (f/k/a Sutton Place Gourmet, Inc.) ("Borrower") and FINOVA CAPITAL CORPORATION, a Delaware corporation ("Secured Party") entered into certain Trademark Security Agreements dated as of December 20, 1996 (the "1996 Trademark Security Agreement") and dated as of June 22, 1999, as amended by that certain Amendment to Trademark Security Agreement dated as of September 23, 2003 (the "1999 Trademark Security Agreement" and collectively with the 1996 Trademark Security Agreement, the "Security Agreements"), both as amended, supplemented or otherwise modified from time to time, by and among Borrower and Secured Party; and

WHEREAS, pursuant to the Security Agreements Borrower granted a security interest in favor of Secured Party in the trademarks (as such term is defined in the Security Agreements), including, but not limited to those Trademarks set forth on Exhibit A attached hereto and made a part hereof (the "Marks"); and

WHEREAS, the 1996 Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on January 2, 1997 at Reel 1554, Frame 0018; and

WHEREAS, the 1999 Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on August 4, 1999 at Reel 1941, Frame 0045 and again on August 19, 2002, at Reel 2567, Frame 0227 and amended on October 6, 2003, at Reel 2839, Frame 0591; and

WHEREAS, Secured Party desires to: (i) release the security interest in the Marks; (ii) waive all of its right, title and interest in such Marks, and restore all such right, title and interest to the Marks to Borrower; and (iii) dissolve any and all liens and encumbrances respecting the Marks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby releases its security interest in the Marks, terminates the Security Agreements, and releases and relinquishes any and all right, title and interest each of them has in and to the Marks, including but not limited to those recorded as reference on Exhibit A.
