WHEREAS, Assignor, Assignee and Stratosphere Gaming LLC have entered into that certain Intellectual Property Assignment and License Agreement, dated as of February 20, 2008 (the "IP Assignment Agreement"), pursuant to which Assignor conveyed, assigned and transferred certain intellectual property, including the Trademarks, to Assignee;

1. Assignment. Assignor hereby conveys, assigns and transfers to Assignee and its successors and assigns all of Assignor's right, title and interest in and to the Trademarks.
2. Purpose. This Assignment has been executed and delivered by the Assignor for the purpose of recording the assignment herein with the United States Patent and Trademark Office. The assignment granted herein has been granted in connection with the IP Assignment Agreement and is expressly subject to the terms and conditions thereof. In the event of any conflict between the terms of this Assignment and the terms of the IP Assignment Agreement, the terms of the IP Assignment Agreement shall control.
3. Counterparts. This Assignment may be executed in any number of counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.


