RELEASE AND TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY


This RELEASE AND TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "**Release**") by and between STATE STREET BANK AND TRUST COMPANY, a Massachusetts Trust Company with its principal place of business at 225 Franklin Street, Boston, Massachusetts (the "**Lender**") in favor of ANNALEE MOBILITEE DOLLS, INC., a New Hampshire corporation with its principal place of business at 50 Reservoir Road, P.O. Box 708, Meredith, NH 03253-0708 (the "**Borrower**") is evidenced by the documents attached hereto, indicating the following:

WHEREAS, pursuant to the term and conditions of that certain Security Agreement, dated as of May 30, 1997 (as the same may have been amended, restated, supplemented or modified, from time to time, the "**Security Agreement**"), the Borrower granted to the Lender a security interest in certain intellectual property, including patents, and copyrights and all of the rights, title and interests of the Borrower in and to (a) the trademarks and service marks described and listed in **Schedule A** attached hereto (the "**Collateral**") in order to secure all indebtedness, obligations and liabilities of the Borrower to the Lender (collectively, the "**Secured Obligations**"); and

WHEREAS, as evidenced by the documents dated April 22, 1998 and April 23, 1998 attached hereto, in consideration of the full payment by the Borrower of the Secured Obligations, the parties agreed that the security interest and lien on the Collateral should be released, terminated and discharged.

Borrower now respectfully requests recordation of such Release in the U.S. Patent and Trademark Office (USPTO) with respect to all the trademark registrations and applications listed in Schedule A.
