enjoyed by Assignee for its own use and benefit, and for the use and benefit of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made.



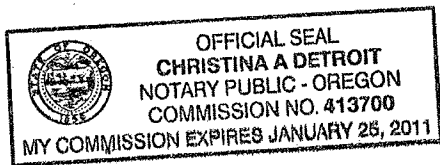
