**ASSIGNMENT OF TRADEMARKS**

This ASSIGNMENT OF TRADEMARKS (this "Assignment") is made effective as of the 29<sup>th</sup> day of June, 2007, by Seattle Mortgage Company, a corporation organized under the laws of the State of Washington ("Assignor"),

**WITNESETH:**

WHEREAS, Assignor is the owner of the following trademarks and the good will of the business to which they pertain, which trademarks it has used in its reverse mortgage business: REVERSE MORTGAGE OF AMERICA, REVERSEWARE, and THE INDEPENDENCE PLAN (the "Trademarks"); and

WHEREAS, Assignor is the owner of record of the trademark registrations for REVERSE MORTGAGE OF AMERICA, U.S. Reg. No. 2994678, and REVERSEWARE, U.S. Reg. No. 75292098 (the "Trademark Registrations"); and

WHEREAS, Assignor conveyed to Bank of America Corporation all of its right title and interest in and to the Trademarks together with the good will of the business to which they pertained and the Trademark Registrations by separate Asset Purchase/Liabilities Assumption Agreement dated as of April 25, 2007, which closed June 29, 2007.

NOW THEREFORE, Inconsideration of these premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor executes and delivers this Assignment to Assignee.

1. Assignor hereby sells, assigns and transfers unto Assignee its entire right, title and interest of every kind in and to the Trademarks, the goodwill of the business to which they pertain and the Trademark Registrations, together with all rights to sue or recover and retain damages and costs and attorneys' fees for past, present and future infringement or misappropriation of any of the foregoing in all countries of the world.

2. Assignor further agrees to execute and deliver all other instruments and do all other lawful acts reasonably necessary or appropriate in connection with the prosecution, extension, assignment, enforcement or defense of each and every trademark registration application, registration or filing based upon the Trademarks or Trademark Registrations, without further compensation, but at the expense of Assignee or its successors and assigns. Assignor hereby authorizes and requests the officials of all countries in which the applicable Trademarks are now registered or in the future will be registered to grant to the Assignee all of Assignor's right, title and interest in and to the same for the sole use and benefit of Assignee, its successors and assigns.
